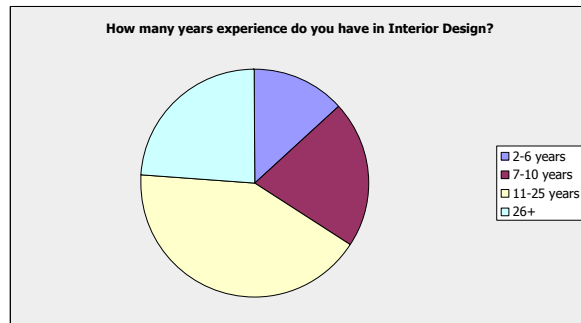


Your Interior Design education came from what school?

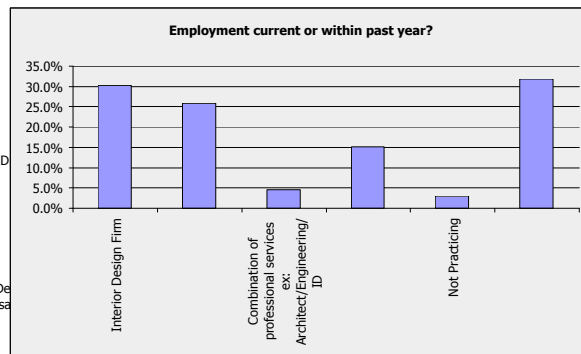

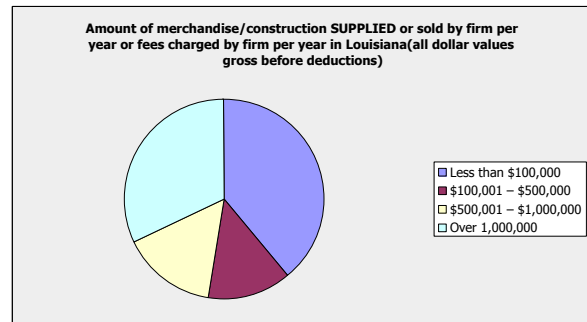

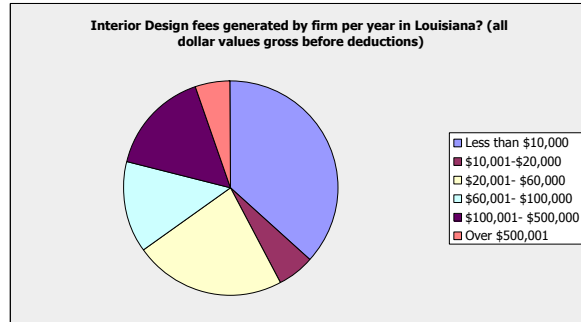

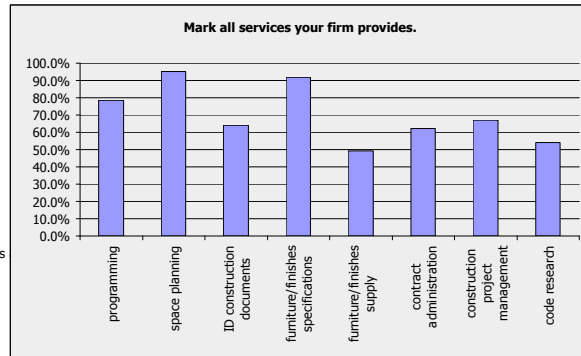
